Resolution No.1-171 of 2015

RESOLUTION OF THE PARKING AUTHORITY OF THE CITY OF EAST ORANGE ESTABLISHING CERTAIN PARKING RATES AND TIMES

WHEREAS, in order to, among other things, operate and/or manage parking facilities located within the City of East Orange (the "City"), the Mayor and Council of the City, pursuant to Ordinance No. 14 of 1970, duly adopted March 9, 1970, as amended and supplemented (the "Creation Ordinance") and the Parking Authority Law of the State of New Jersey (the "State"), N.J.S.A. 40A:11A-1 et seq., as amended and supplemented (the "Act"), created and established the Parking Authority of the City of East Orange (the "Authority") as a public body corporate and politic of the State and an agency of the City with all the powers, privileges, and authority conferred by the Creation Ordinance and the Act; and

WHEREAS, the Authority was created to operate and/or manage on-street and other parking facilities located within the City and to enforce applicable law, ordinances and regulations as to the parking of vehicles in the City, and the consequent promotion of free movement of traffic and relief of traffic congestion on the streets of the City and improvement of conditions affecting the public safety and welfare therein; and

WHEREAS, the Authority is authorized under the Creation Ordinance and the Act to. among other things, manage, maintain and operate parking facilities in such manner as in its opinion will provide an effective and satisfactory method for promoting the purposes of the Authority and to set parking fees and other related rules and regulations for permitted use of the Authority's parking facilities; and

WHEREAS, by ordinance of the City, adopted on July 20, 2015, the City amended the Creation Ordinance to provide that the Authority shall set parking rates and maximum parking times for parking meters, lots and other parking facilities owned or leased by, or otherwise within the jurisdiction of, the Authority; and

WHEREAS, the Authority has determined that it is necessary to establish parking rates and times for certain parking facilities.

NOW, THEREFORE, BE IT RESOLVED by the Authority as follows:

- 1. The aforementioned recitals are incorporated herein as though fully set forth at length.
- 2. The rate shall be twenty-five cents (\$0.25) for fifteen (15) minutes, with a maximum parking period of four (4) hours, for on-street spaces controlled by parking meters (including any mechanical device or meter placed or erected for the regulation of parking, "Parking Meters") in the following areas:
