WHEREAS, the Local Public Contracts Law authorizes the purchase of goods and services through a duly-formed cooperative purchasing system without advertising for bids; and

WHEREAS, the procurement of goods and services through a cooperative purchasing program is considered to be an open and fair process under the "Pay-to-Play Law," N.J.S.A 19:44A-20.4 et seg.; and

WHEREAS, the Authority has duly considered participation in a Cooperative Pricing System for the provision and performance of goods and services;

NOW, THEREFORE, BE IT RESOLVED as follows:

TITLE: This resolution shall be known and may be cited as Resolution No. 2 of 2016 Cooperative Pricing Resolution of the East Orange Parking Authority.



AUTHORITY: Pursuant to the provisions of the Local Public Contracts Law, the Chairman is hereby authorized to enter into a Cooperative Pricing Agreement with the Lead Agency by executing the attached Cooperative Pricing Agreement Rider and

submitting same to the Lead Agency along with any additional documents as may be required.

CONTRACTING UNIT: The Lead Agency shall be responsible for complying with the provisions of the Local Public Contracts Law and any other applicable provisions of law.

EFFECTIVE DATE: This resolution shall take effect immediately upon passage.
